At her public school, Genevieve was behind the other students and the teachers weren’t offering the extra help she needed. Also, Ms. Hernandez complained that she could see her daughter getting caught up with the wrong crowd.

After winning a scholarship, Ms. Hernandez enrolled her daughter at St. Joseph’s School in Long Island City, Queens. Although Genevieve had to repeat 4th grade, her mother thinks the one-on-one attention and after-school tutoring at St.

Joseph’s is paying off. She’s now in 7th grade.
